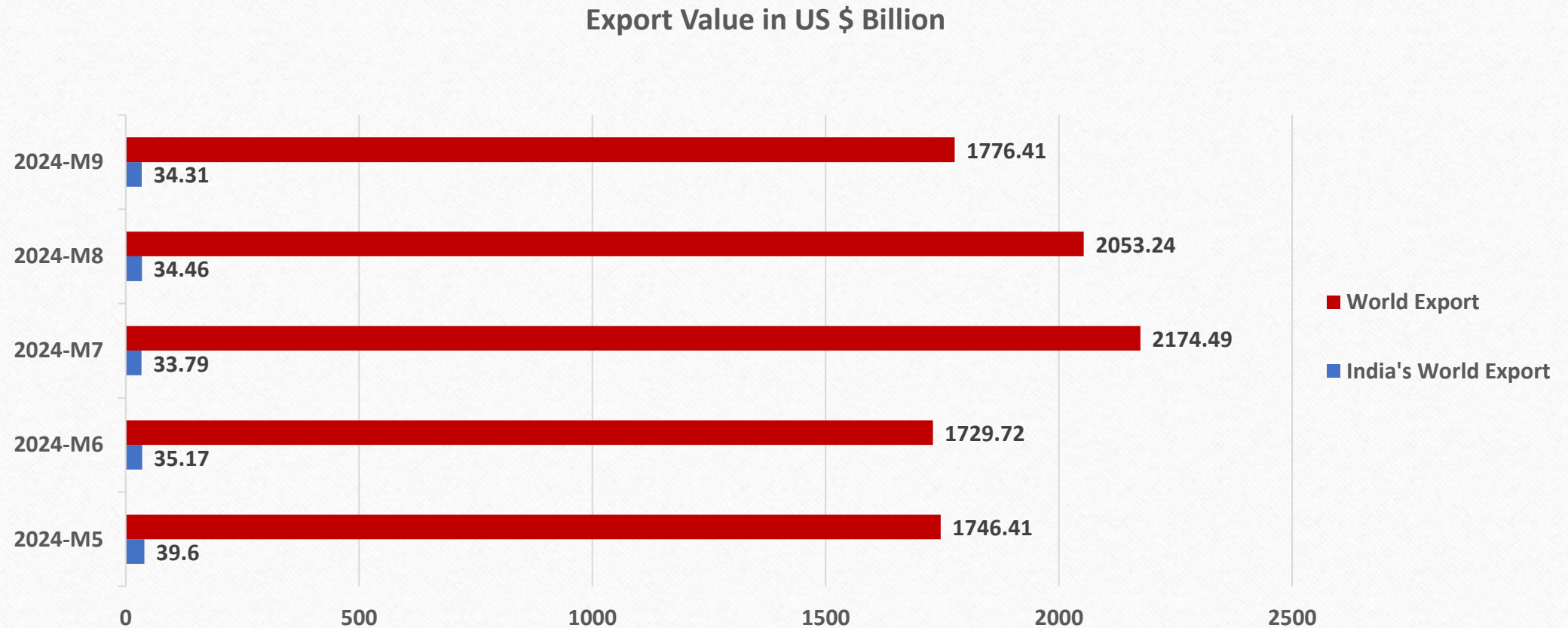

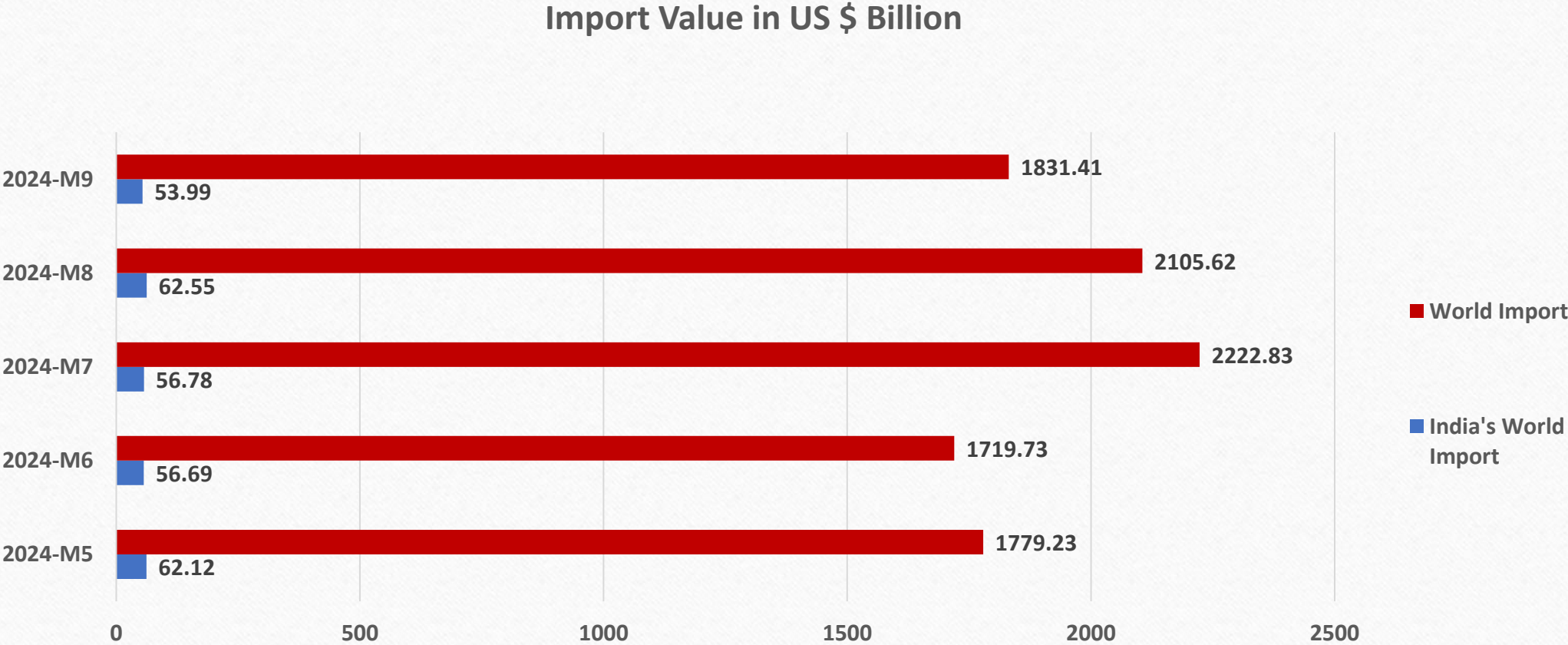

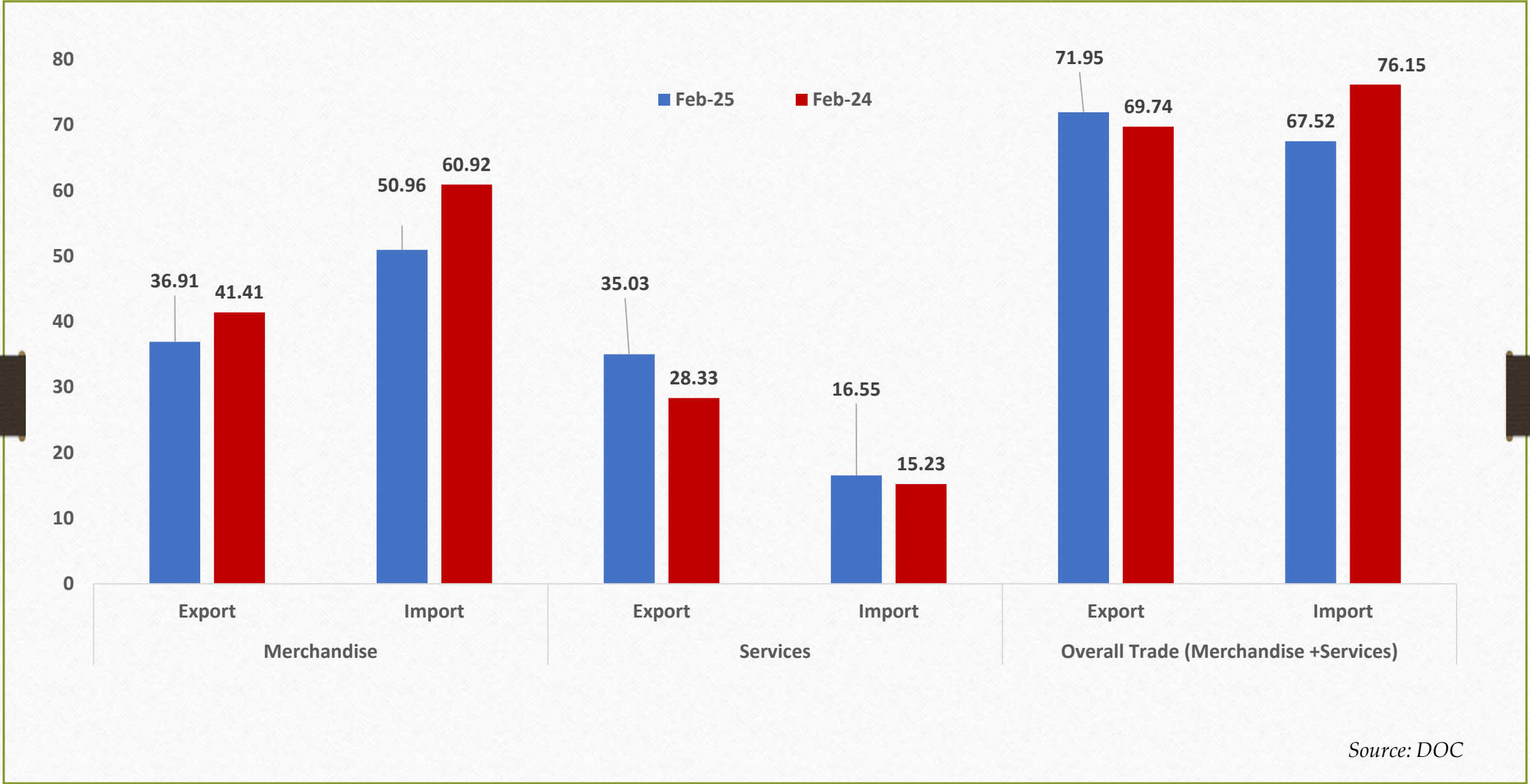

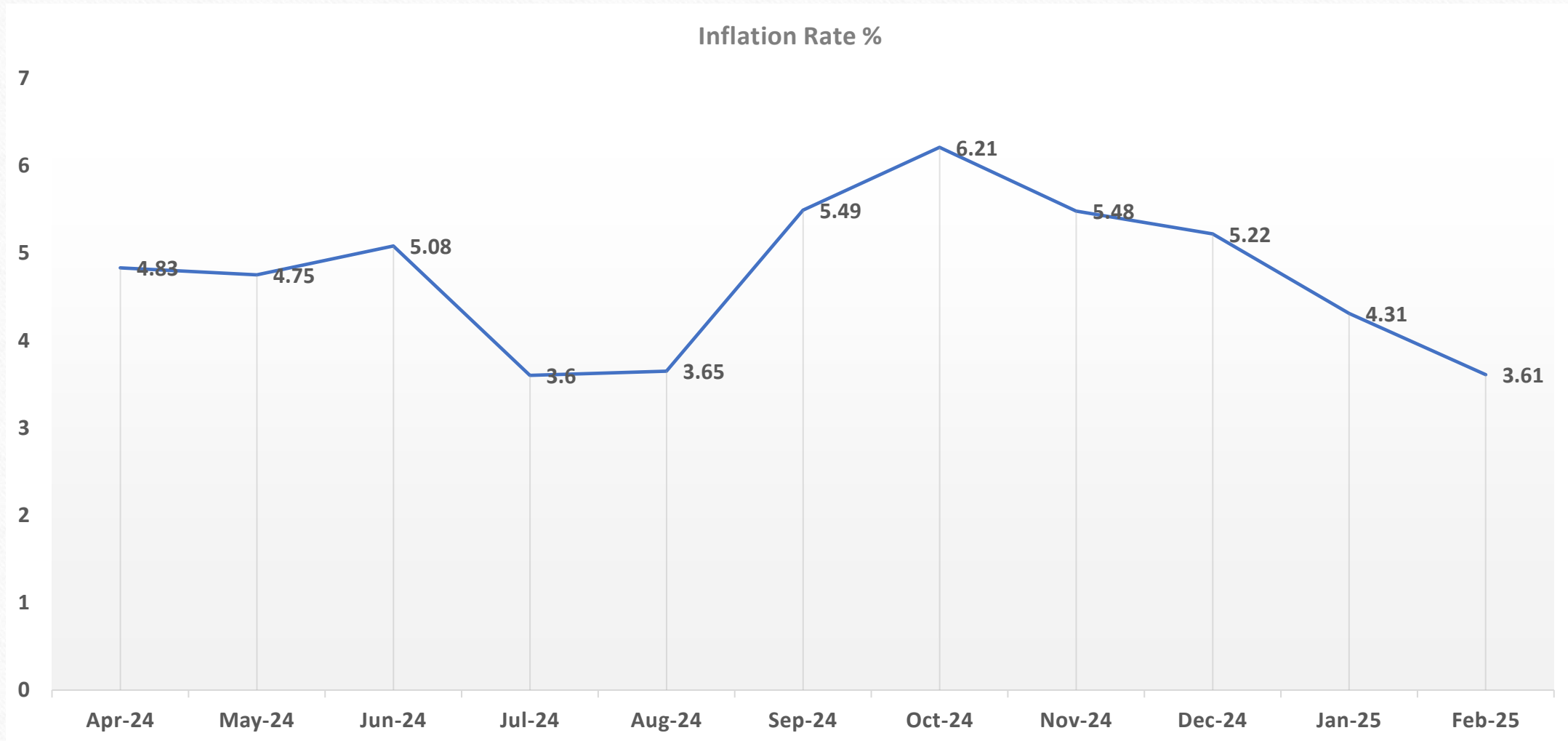

1	Stainless Steel Pipes and Tubes (Quality Control) Order, 2025	Stainless Steel Seamless pipes and tubes for general service and Stainless Steel Welded pipes and tubes for general service	11th February 2025	730411, 730422, 730423, 730424, 730611, 730621, 730630	Provided further that nothing in this order shall apply for five hundred kilograms of goods or articles imported for the purpose of research and development by manufacturers of stainless steel pipes and tubes per year with the condition that such imported goods and articles shall not be sold commercially and can be disposed of as a scrap and the manufacturer shall maintain a year-wise record of such goods or articles and furnish to the Central Government: Provided also that nothing in this order shall apply to goods or articles domestically manufactured or imported before the date of commencement of this order by the manufacturer certified by the Bureau or manufacturer who has applied to the Bureau for certification and such manufacturer shall be permitted to sell or display or offer to sell such declared stock up to six months from the date of implementation of this order with the condition that such manufacturer shall made a declaration to this effect to the Bureau.

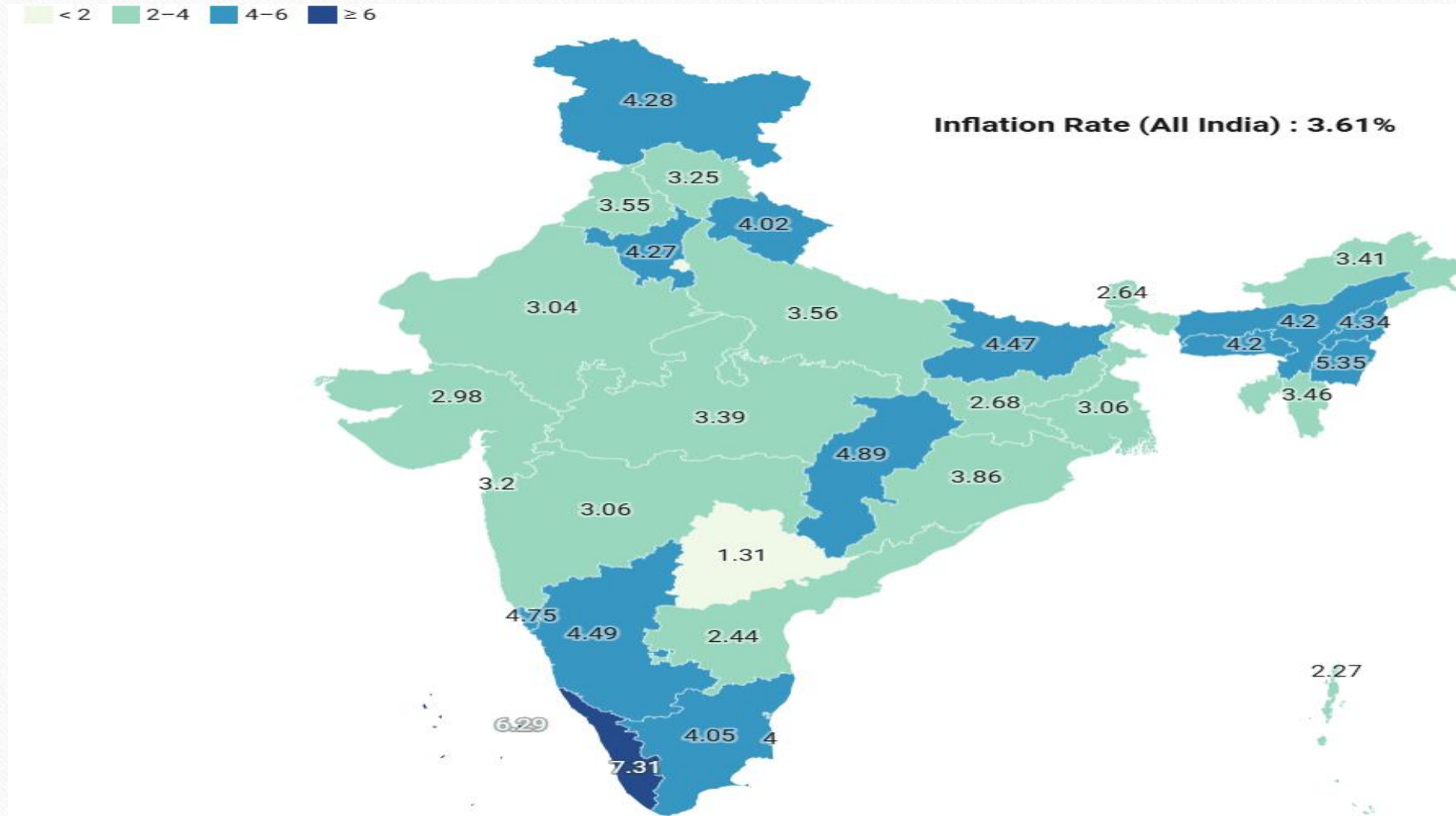
