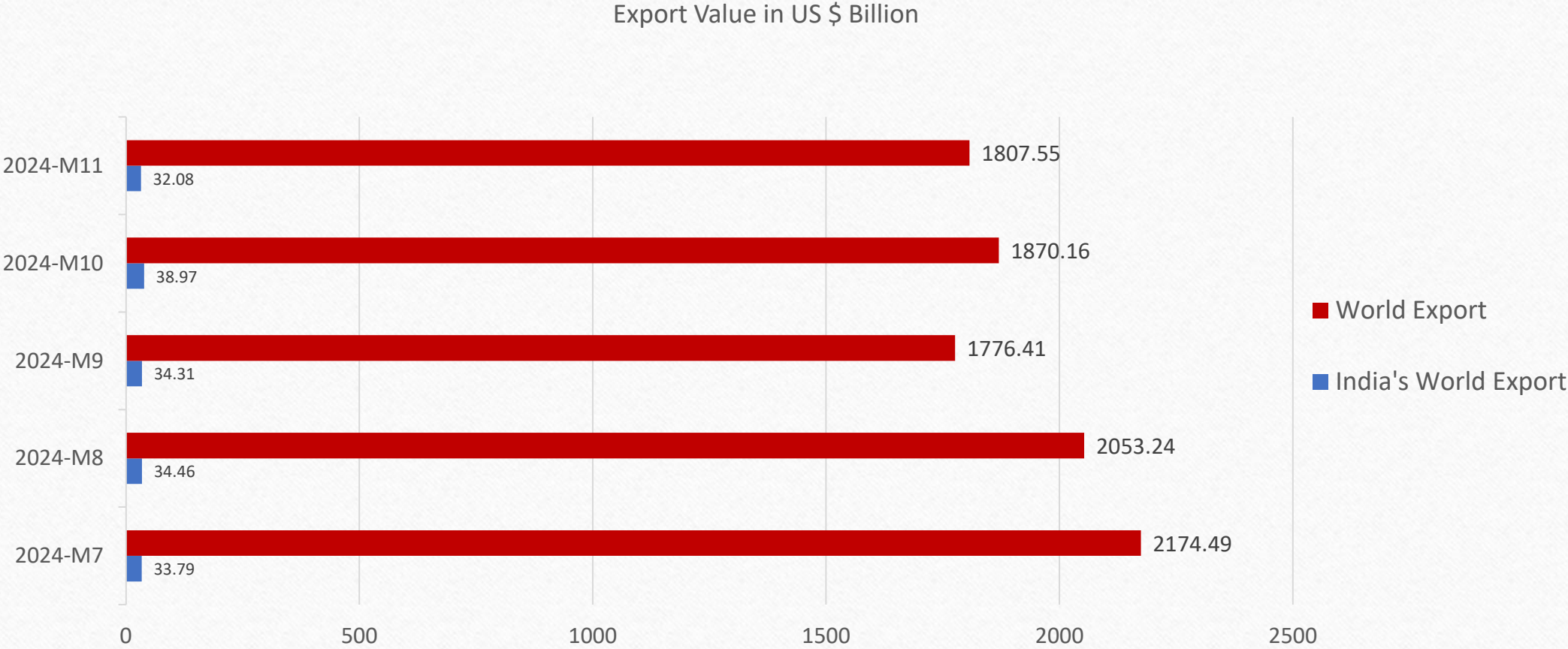

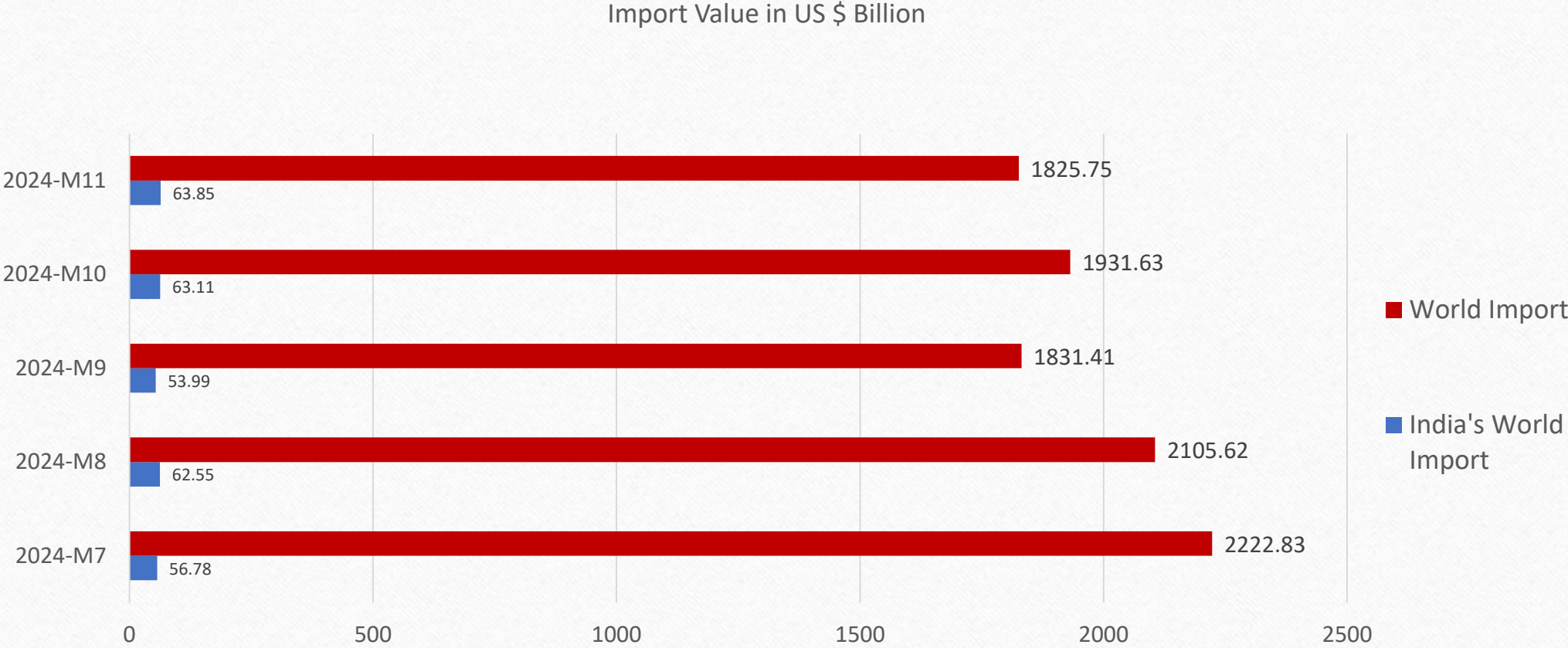

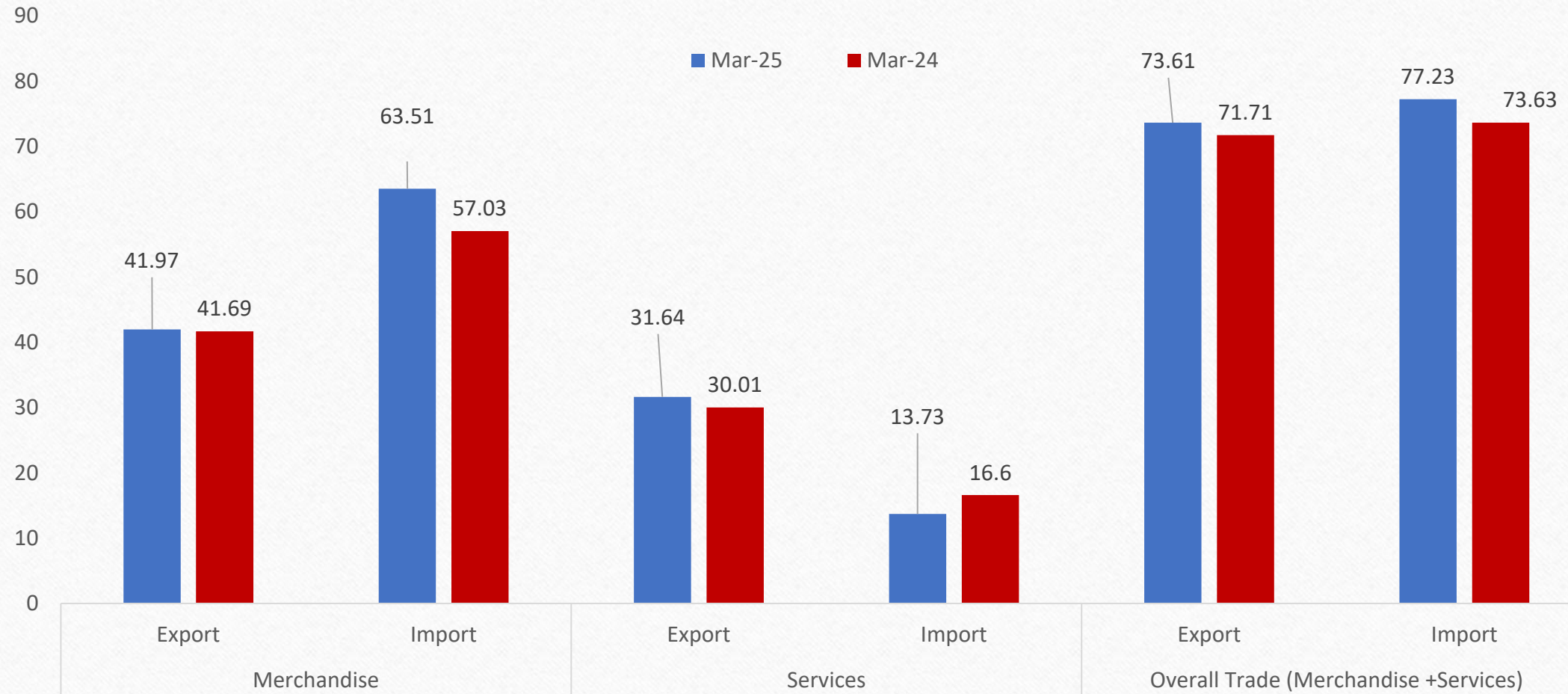


Month Wise India's & World Import Trade in July 2024 to November 2024 (Value in US\$ Billion)

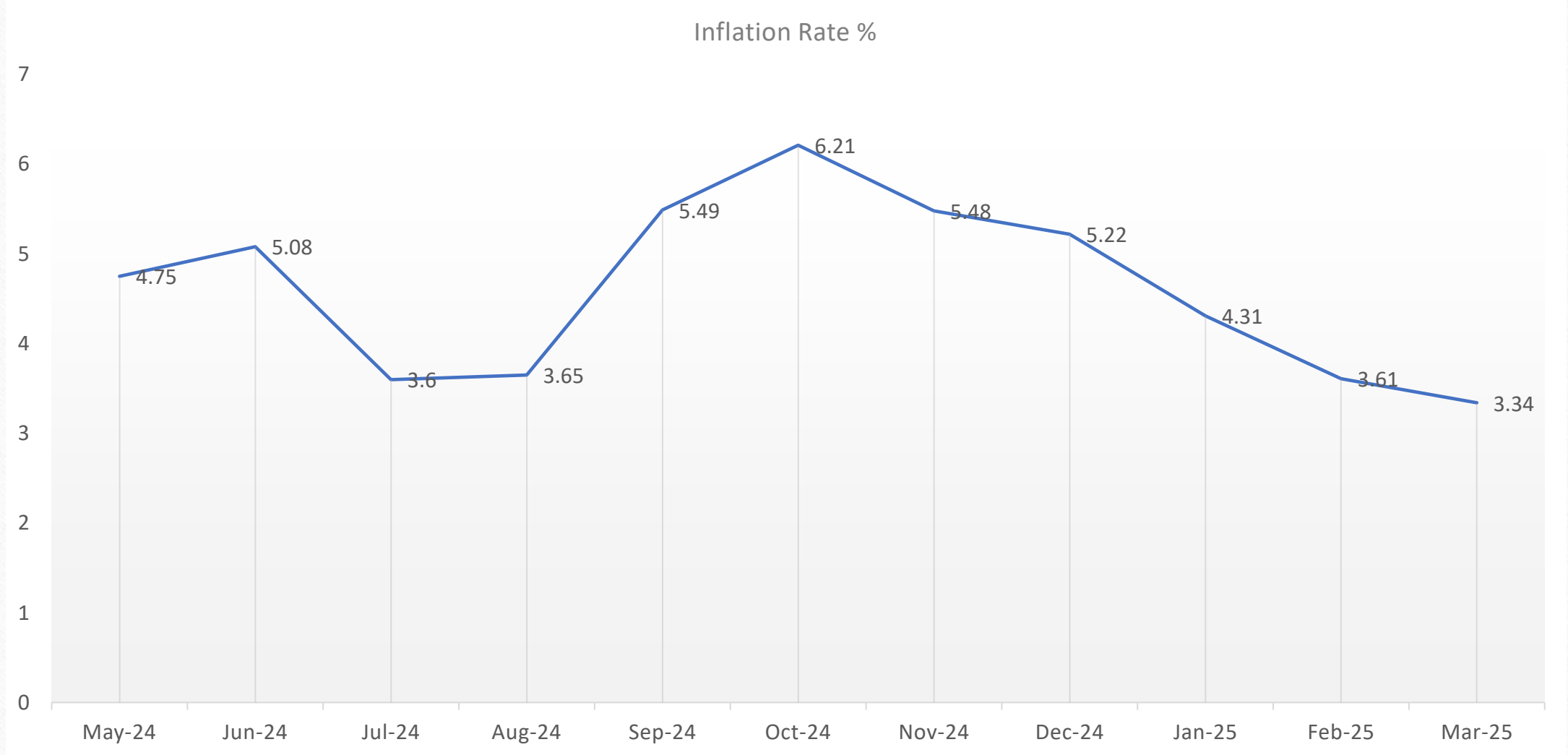

## Month Wise Quality Control Orders Issued By India (February 2025)

Sl. No.	Quality Control Order	Products covered	Date of Issue	HS Codes	Description
1	Furniture (Quality Control) Order, 2025	Work chairs, General purpose chairs and stools, Tables and desks, Storage units, Beds, Bunk beds	14th February 2025	940320, 940330, 940350, 940360	Provided further that nothing in this order shall apply to micro and small enterprises as defined in clauses (h) and (m) respectively of section 2 of the Micro, Small and Medium Enterprises Development Act, 2006 (27 of 2006), till the expiry of eighteen months from the date of publication of this notification: Provided also that nothing in this order shall apply to goods or articles manufactured domestically by an enterprise, registered under "Udyam Portal" of the Ministry of Micro, Small and Medium Enterprises, wherein the investment in plant and machinery or equipment at original cost does not exceed twenty-five lakh rupees and the turnover does not exceed two crore rupees for the previous financial year as certified by a Chartered Accountant shall be exempted from implementation of this order.

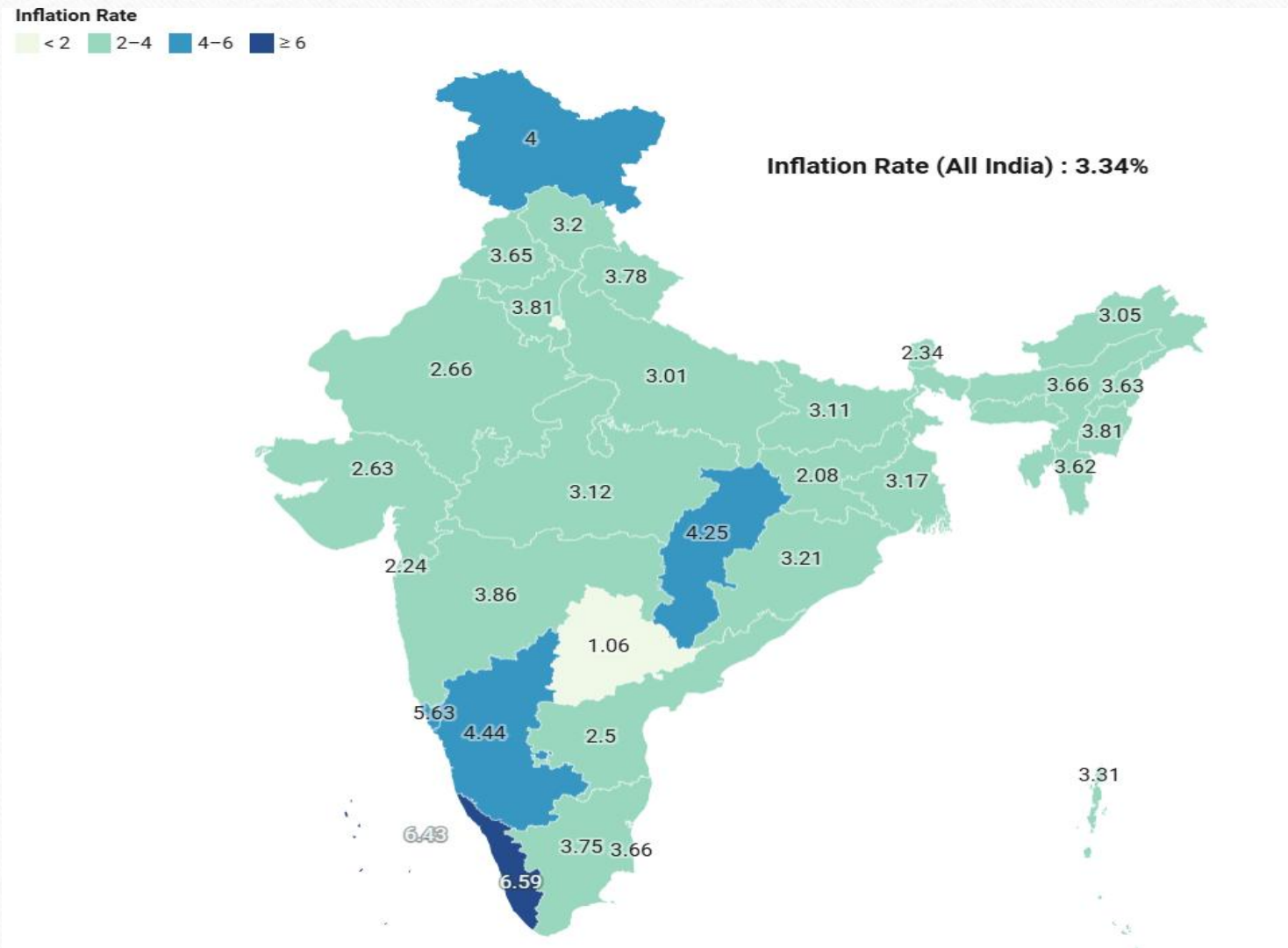
## Inflation Rates (May 2024 to March 2025)
